Compliance with technical, administrative, fiscal, environmental and safety regulations is a fundamental value for **Solar IT SrI** that characterizes its processes and relations with company personnel.

From an operational point of view, the Management encourages the following behaviors:

## A – The people

Solar IT:

## **C – Respect for the Environment**

- The company believes in respecting the environment in all phases of its business processes, also through the choice of supplier companies that comply with current environmental regulations;
- encourages the separate collection of waste at its premises, in accordance with local regulations;
- manages the aspects of design, construction and operation of technological systems with criteria aimed at
  preventing pollution, reducing environmental impacts, preventing possible accidental events, maintaining the
  biodiversity of the reference ecosystems, adopting the best techniques available on the market to this end and
  verifying the behaviour of the reference companies in the construction, operation and maintenance of the plants;
- collaborates with institutions for the promotion of the values of the development of a new sensitivity towards the environment and the community.
